5. **[Migratory Bird Hunting; Migratory Bird Hunting Regulations on Certain Federal Indian Reservations and Ceded Lands for the 2022-23 Season](#)**

This rule allows the establishment of season bag limits and, thus, harvest at levels compatible with populations and habitat conditions.

 - Support a process to develop an urban Indian organization confer policy to ensure the Secretary confers, to the maximum extent practicable, with urban Indian organizations; and
 - With the Secretary's written approval, conduct other duties as recommended by the Committee.

18. [Partition, Disaggregation, and Leasing of Spectrum](#)

- The Federal Communications Commission (Commission) gives notice of final rule that modifies partitioning, disaggregation, and leasing rules to provide specific incentives for small carriers and Tribal Nations, and entities in rural

areas, to voluntarily participate in the Enhanced Competition Incentive Program (ECIP).

- The ECIP will promote greater competition in the provision of wireless services, facilitate increased availability of advanced wireless services in rural areas, facilitate new opportunities for small carriers and Tribal Nations to increase access to spectrum, and bring more advanced wireless service including 5G to underserved communities.
